Standard Guidelines and Release Form**

Please sign and return to the FHS office by Fri. May 19, 2017:

FHS Release Form

To ensure the event's success, these guidelines have been set by the FHS Grad Night Committee:

1. Only graduated Franklin Seniors are eligible to attend and must show I.D. at check in.
2. Alcoholic beverages and drugs are prohibited.
3. **NO CELL PHONES OR BACKPACKS ARE ALLOWED AT THE PARTY.** Except for swimming suits and accessories related to swimming, no personal items will be allowed into the party venue. If you bring your cell phone or personal items, they will be checked in at the Grad Night registration in the FHS gym the night of graduation and held in a secure location until we return to FHS.
4. Students meet in the Memorial Coliseum venue (after graduation).
5. Graduates must take the event bus to and from party location.
6. It is recommended that students not leave their cars at Franklin. Please arrange to be dropped off at Memorial Coliseum on Tuesday, June 6, by 10 p.m., and picked up at Franklin@Marshall at 6 a.m.. on Wednesday, June 7
7. Once the graduates enter the FHS gym, they are in a secured environment and are not allowed to leave except to board the bus to the party location.
8. **Students will not carry bags or personal belongings onto the bus, except for swim suits and accessories related to swimming. Towels will be provided at the venue.**
9. Any student violating these rules will be removed from the party and **MUST** be picked up by their parent/guardian.
